



ST LEO'S COLLEGE - CONDITIONS OF ASSOCIATE MEMBERSHIP 2019

St Leo's College (**the College**) is a Catholic institution which provides collegiate Associate Membership for male students undertaking tertiary studies.

The College undertakes:

- to encourage the pursuit of academic excellence;
- to provide support services, such as tutorials in selected courses and access to computers, printers and photocopiers during the academic semesters only; and
- to provide access to pastoral care and to encourage a faith commitment.

Students entering the College and their parents must acknowledge that while the College will assist and encourage Associate Members in all aspects of their lives at the University, the students are entering an adult environment and they must accept responsibility for their studies, their administration, their conduct, their grades, and their own safety.

Persons who take up Associate Membership must undertake:

- to recognise the Catholic nature of the College with a code of conduct both within and outside the College, and commit themselves to Christian and academic values and the practice of same;
- to apply themselves to their studies and agree to the College reviewing their performance;
- to contribute to the College Community, commensurate with their interests and abilities;
- to conduct themselves in a manner which recognises the rights of others and discourages any form of discrimination or bullying;
- to behave at social, cultural and sporting functions, either as participants or as spectators, in a manner which reflects credit on both the College and the Church;
- to indemnify the College from any blame for injuries received while participating in sporting, social or cultural activities;
- to accept responsibility to make restitution for any damage caused by themselves or persons invited as their guests; or who gained entry to their rooms because of failure to secure their rooms;
- to abide by the rules promulgated in the College Handbook, on notice boards; and by whatever other means used by the Head of College;
- to comply with the College Alcohol policy;
- to bring on to College premises only Australian Standard appliances; that have validly tested and tagged or submit the appliance to be tested and tagged;

- to bring on to College premises only medications that have been prescribed by a registered medical practitioner;
- to not bring onto or consume on the College premises any recreational drugs, illegal substances or apparatus such as “bongs”; Refer 14.14
- to refrain from consuming alcohol until 18 years of age;
- to be a responsible consumer of alcohol;
- to accept responsibility for damage caused to themselves, others or property as a result of the consumption of alcohol;
- at all times when operating a motor vehicle on the College and University premises, to do so with respect for the law, safety and wellbeing of themselves, others and property;
- to comply with all rules and regulations relating to guests of Associate Members, including directions as to when guests are permitted at the College and the conduct of guests while at the College;
- to comply with all policies regulating the usage of the internet, internet based programs and materials, electronic devices and mobile phones;
- to follow all reasonable directions of College staff; particularly in relation to directions about the safety and wellbeing of themselves, others and property;

Acceptance of these **Conditions of Associate Membership** is a prerequisite for admission to the College. Parents/guardians and prospective Associate Members both must read these **Conditions** and the rules and regulations promulgated in the **College Handbook**, and acknowledge acceptance of them.

Failure to honour the conditions of this agreement may result in penalties ranging from fines or probation or suspension to a direction of an Associate Member to withdraw from the College, depending on the severity of the action involved.
